A GOOD APPOINTMENT

Congressman Smith is to be congratulated on his choice of Lyman M. King of Redlands as census supervisor for this congressional district. Mr. King is editor of the Review of that city and has had some prominence in politics as one of the Republican electors at the last election and chairman of the county committee. For a number of years he has been treasurer of the state hospital at Patton and secretary of the board of managers. In this position he has shown excellent clerical ability and capacity for organization and administration. These are qualities that will come in good play in the census work. King is well informed regarding conditions in the various counties of the district and is sure to name a set of enumerators who will do their work with thoroughness and competency. In every way the appointment is a good one and it will be received with general favor throughout the district.

We notice that San Diego is registering something of a kick because the appointment was not given to a San Diego man. The city of bay and climate seems to think that it has some special claims to consideration at the hands of the census takers that will be best served by the supervision of a resident of San Diego. All that San Diego is entitled to, however, is an accurate count and that Mr. King will, we have no doubt, see that this is given.

The enumerators will be taken from San Diego county and we know of no outside influence that will prevent their counting every man, woman and child in the county at the time the census is taken. If the idea has been to have them count a few more, of course that arrangement might be facilitated by San Diego supervision. We do not wish to be understood as intimating that such is the case, but there is something a trifle suggestive about the claim that San Diego has some special interest in the census that could best be protected by a San Diego man for supervisor. Riverside will be very glad to trust the appointment of enumerators and supervision of the work of enumeration to as square and competent man as Lyman King; and if it is a square deal and no more that San Diego wants, she need have no protest to make on his appointment.

PROHIBITION IN CALIFORNIA

The following item appears in the last issue of the Los Angeles Graphic: According to a statement given out by Chairman Leonardson of the State Prohibition party, Del Norte, Imperial, Kings, Orange, Riverside, San Diego, Sutter and Ventura counties now are wholly "dry." Plumas since has been added to the number, while, with the exception of Alturas, Modoc county belongs to the same list. Precinct option exists in Alameda, Colusa, Lake, Los Angeles, San Bernardino, Santa Barbara and Yolo counties. The wholly "dry" cities or towns are Azusa, Corona, Corning, Fowler, El Centro, Imperial, Kingsburg, Monrovia, Ontario, Oceanside, Pomona, Porterville, Selma, Tulare, Upland, Whittier, Winters and Braley. Mr. Leonardson may be an authority on third party politics, but judging from this statement he has only a very limited idea of the great work that has been done in closing the saloons in California, not by the Prohibition party, but under the leadership of the Anti-Saloon League. Is there any reason why a man who is presuming to discuss local option in an authoritative sort of a manner should omit from the list of no saloon cities the following: Riverside, Pasadena, Redlands, Santa Ana, Ventura, Long Beach, Fresno, Santa Paula, Elsinore, and San Jacinto? That is a list almost as long as the one given by Mr. Leonardson and we do not claim that even that completely supplements his. We would suggest that he visit the headquarters of the Anti-Saloon League and find out what is really being accomplished in the temperance warfare in California; he will never learn from any information that is available at the headquarters of the Prohibition party.

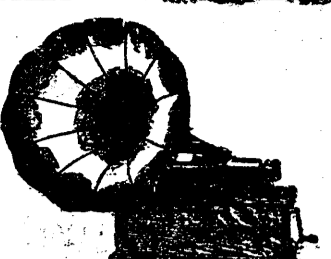

In starting a fire, gasoline by mistake was used instead of coal oil, and when a match was applied the whole room was a mass of flames. The child attempted to run through the room and in so doing was badly burned about the face, hands and shoulders. It is reported that the child's eyes were injured. The family had but recently removed to Claremont, after a residence in San Jacinto of twenty years.

World of Politics

Democrats of Massachusetts will meet in convention in Faneuil Hall, Sept. 30, to name candidates for governor and other state officers.

A plot is said to be hatching in Arkansas to change the rules governing the Democratic state primary with a view to defeating Senator Jeff Davis for re-election.

The progressive and stalwart factions among the Republicans of South Dakota are already preparing for a bitter fight over the governorship next year.

The Commercial club of Trpeka, Kans., has taken the initial steps to bring about a referendum vote on the commission form of government for that city this fall.

A story printed in Des Moines says that Governor B. F. Carroll is planning to run for congress in the Sixth Iowa district and will not ask for re-nomination as governor.

The platform recently adopted by the Maryland Democratic convention favors the suffrage amendment to the State constitution to be voted on this fall, which in effect disfranchises the illiterate negro vote.

Eastern political gossip credits Senator Cummins of Iowa with possible designs on the presidency in 1912. If the report is true, politicians believe he will make his fight on "a tariff commission" issue.

The senatorial contest in Mississippi has reached an interesting stage. Hon. A. J. McLaurin, the incumbent, and ex-Governor J. K. Yardaman are already avowed candidates and it is now rumored that a third aspirant may enter the race for the top.

Perhaps some of those lands have since been withdrawn, in the interest of conserving the public resources. Perhaps the failure to withdraw more is due to the omission of congress to enact necessary laws empowering the withdrawal. Perhaps Ballinger is sincerely devoted to the policy of conservation, and is only restrained from radical action by his greater devotion to the integrity of the law. No matter, good or bad, it is a waste of breath to make this defense to the people. The popular mind simplifies all issues, and preferably reduces them to persons. Sometimes it is unjust in doing this, but usually it comes much nearer a just conclusion than it could by attempting to pass in expert judgment on an expert controversy. The public hears plenty of arguments which it is not equipped to refute, but it does not therefore believe them all. And an intelligent appreciation of the limits of public discussion will recommend to Secretary Ballinger and his apologists not to attempt the impossible. If the secretary is right, the people can be convinced, but not that way. The way is simpler. The people
